### Description and definition of the product function:

The pressure converter series **TMG -Z/JB** is intended for measuring pressure levels in gas and liquid media. It works as a passive component of measuring and regulation systems where it converts the input pressure signal to the continuous output electric signal with values  $0.2 \div 1$  mA or  $4 \div 20$  mA. For the use for group I M1, it is connected to the intrinsically safe circuit of the associated apparatus – PNS boxes of the system of remote power supply and transmission MTA 11 (e.g. PNS 02, PNS 03 or PNS 04). The allowed range of the regulated power supply is  $12 \div 22$  Vdc. For the use for the group of devices II 1G, the supply ZS-030 (producer JSP Nová Paka) is exclusively used for power supply. Detailed use of transmitters is described in "Instructions for operating, assembly and maintenance" arch. No.206002.02, which is an integral part of the transmitter delivery. The TMG version of the transmitter is intended for measuring relative pressure, TMVG for measuring underpressure, TMDG for measuring differential pressure and TMAG for measuring absolute pressure.

The product is constructed as a device of category I M1 Ex ia I Ma and a device of category II 1 G Ex ia IIB T4 Ga. So it is classified in conformity with the article 1.0.5. of the annex no. 2 NV 23/2003 Coll.

#### **Technical measures**

Properties of this product fulfil the technical requirements which are stated in:

Government decree no. 23/2003 Coll., which determine technical requirements for devices and protection systems designated for use in environment with the danger of explosion.

The judgement of conformity was made according to § 3, par. 1 and this Government decree, securing production quality is made according to annex no. 4 to this Government decree.
